Unit History of Company "F", 40th Armor SUBJECT: (Second Quarter of 1970)

- 1. On the 17th of April. Brigadier General HAROLD I. HAYWARD visited Turner Barracks to present the Commanding General's Tank Gunnery Trophy to the outstanding tank crew for the fiscal year 1970. The high tank was F-22 commanded by SGT JAMES S. LEFLER. His crew members were: Gunner: SP5 LUTHER J. LaRUE, Driver: SP4 ROBERT M. GOMEZ, Loader: PFC HENRY W. McCALL. The crew was awarded a plaque to be displayed on F-22 in parades and each man received \$25.00 cash award for his superior performance on the Grafenwoehr Tank Crew Qualification Course.
- 2. The tank small arms were augmented on the 21st of April when Company F. traded the M-73 machineguns for the M-73 E-1 Coaxial machineguns. This new weapon came with glowing reports of its outstanding performance in field testing in Grafenwoehr.
- 3. The annual celebration of the birthday of St. George, the patron saint of the cavalry, took place in several events hosted by our French counterpart unit in Berlin, the 11th Regiment of Chasseurs. Festivities started in the evening of the 21st in a non-tactical bivouse in the French Heiligensee training area. 1LT DOUGLAS S. AYKROYD and his four men were very well fed with French rations which

- included wine, bread, and commercial canned goods. On the 22nd the Regimental Rallye (an Armor Stakes type event) carried participants over a twenty kilometer course. That night the entire regiment paraded in an impressive torchilght review. Finally, the next day was dedicated to traditional toasts, banquets and a final party.
- 4. The Honorable THADERUS AR BEAL, Under-Secretary of the Army, visited Turner Barracks on the 27 on April. A briefing and static display of vehicles were set up so that the Under-Secretary could better understand the company sission and see the means we have at hand to accomplish the sission. He then went to the Four Ring where Pirst Platon had set up an Immediate Ready Force display with the 2nd Battallon, 6th Infantry. Characteristics of the Under-Secretary's visit was his conversation with every soldier.
- 5. On the 29° of April, Company P hosted a visit with a troop from the 13°/18° Royal Hussars, who were in Berlin while most of A Squadron, 9°/12° Royal Lencers were on parade in England. It was the first opportunity for the British cavalry men to get a good look at American Tanka.
- 6. The first days of May were highlighted by our British counterpart unit, A Squadron, 96/128 Royal Lancers. On the 48 of May, one troop of three tanks and the trucked vehicle retriever (from the units Light Aid Detachment) came to the company area. While we were very lapressed by their denonstration of their stabilized gun, our VFM defeated theirs in a tug-of-war. That Friday the Fourth Platoon returned the visit by taking five tanks to Sauts Barracks. Rides on the Ferret Soout Car were very popular among our troops who had no experience with a lightly armored wheeld webficle.
- 7. On 9 May Captain PHILIP D. RILEY was married to the former Carol ann Hayward, daughter of the Berlin Brigade Commander. After a lively reception in the Harnak House, the couple left for a honeymoon in Majoros.
- 8. The rest of the month was spent in preparation for the Allied Forces Day Parade on the 25rd. After many hours of late night painting sessions and early morning practices, the parade started. Despite warnings of student extremist demonstrations, the parade was manufactured to the VTA. "Drigadier General HAROLD I. HAFMAND complemented the company "for its outstanding appearance and whole-hearted participation" in the parade.
- 9. Elements of five platoons participated in Berlin Brigade PTX "Cartridge IV" from the 25th to the 27th of May. First and Sixth Platoons were attached to 2nd Battalion 6th Infantry as aggressors while Second, Pourth, and Fifth Platoons remained under normal Brigade control. While new techniques (like indirect fire) and (greater Move-ontrol.)

- 10. The last day of May as a member of Company "P" take third place honors in the French Military horse riding-jumping event.
 SF4 ROBERT B. COX, along with Captain WILLIAM FORTER of Berlin Brigade Headquarters, had the fastest time in the international event but were reduced to third place by one fault. It is noteworthy that Specialist COX's horse had been on the course twice without finishing before making the prize winning run.
- 11. The Command Personnel Management Inspection, a new innovation in the Army, bit Company P on the 8° through the 11° of June. As a result of this inspection many errors in personnel records were corrected.
- 12. The 9° of June saw the first use of a tank crew proficiency course set up on Park's Range by 2LT RICHARD L. LOPEZ, Jr. The idea behind the course was to get the Third, Fourth, and Sixth Platoons, then training for Grafenwehr qualification, used to a Range 80 course. Despite the short ranges, the quick lay and crew drills were designed to help the gunnery platoons get the best training available in Berlin.
- 15. Turner Barracks was honored by the visit of forty Scandinavian students on the 16° day of June. After being shown static displays of equipment and vehicles, they were treated to tank rides. A highlight of their visit was the number of individual conversations that took place after lunch in the Company mess.
- 14. Three troopers were found guilty of violations of the Uniform Code of Military Justice during April.
